1     **A Bill for an Act to amend the *Fair Work Act 2009*,**  
2     **and for related purposes**

3     The Parliament of Australia enacts:

4     **1 Short title**

5                     This Act may be cited as the *Fair Work Amendment (State*  
6                     *Referrals and Other Measures) Act 2009*.

7     **2 Commencement**

8                     (1) Each provision of this Act specified in column 1 of the table  
9                     commences, or is taken to have commenced, in accordance with  
10                    column 2 of the table. Any other statement in column 2 has effect  
11                    according to its terms.

2 subsections (7) and (8) apply to the termination;  
3 (c) the State's transition reference terminates.
- 4 (7) A State does not cease to be a *referring State* because of the  
5 termination of its amendment reference if:  
6 (a) the termination is effected by the Governor of that State  
7 fixing a day by proclamation as the day on which the  
8 reference terminates; and  
9 (b) the day fixed is no earlier than the first day after the end of  
10 the period of 6 months beginning on the day on which the  
11 proclamation is published; and  
12 (c) that State's amendment reference, and the amendment  
13 reference of every other referring State (other than a referring  
14 State that has terminated its amendment reference in the  
15 circumstances referred to in subsection (8)), terminate on the  
16 same day.
- 17 (8) A State does not cease to be a *referring State* because of the  
18 termination of its amendment reference if:  
19 (a) the termination is effected by the Governor of that State  
20 fixing a day by proclamation as the day on which the  
21 reference terminates; and  
22 (b) the day fixed is no earlier than the first day after the end of  
23 the period of 3 months beginning on the day on which the  
24 proclamation is published; and  
25 (c) the Governor of that State, as part of the proclamation by  
26 which the termination is to be effected, declares that, in the  
27 opinion of the Governor, this Act:  
28 (i) is proposed to be amended (by an amendment  
29 introduced into the Parliament by a Minister); or  
30 (ii) has been amended;  
31 in a manner that is inconsistent with one or more of the  
32 fundamental workplace relations principles.
- 33 (9) The following are the *fundamental workplace relations*  
34 *principles*:  
35 (a) that this Act should provide for, and continue to provide for,  
36 the following:  
37 (i) a strong, simple and enforceable safety net of minimum  
38 employment standards;

- 1 (ii) genuine rights and responsibilities to ensure fairness,  
2 choice and representation at work, including the  
3 freedom to choose whether or not to join and be  
4 represented by a union or participate in collective  
5 activities;  
6 (iii) collective bargaining at the enterprise level with no  
7 provision for individual statutory agreements;  
8 (iv) fair and effective remedies available through an  
9 independent umpire;  
10 (v) protection from unfair dismissal;  
11 (b) that there should be, and continue to be, in connection with  
12 the operation of this Act, the following:  
13 (i) an independent tribunal system;  
14 (ii) an independent authority able to assist employers and  
15 employees within a national workplace relations  
16 system.

 26 relocation of words or matter), but does not include the enactment  
 27 by a Commonwealth Act of a provision that has, or will have,  
 28 substantive effect otherwise than as part of the text of this Act.

29 ***fundamental workplace relations principles***: see subsection  
 30 30L(9).

31 ***initial reference*** of a State means the reference by the Parliament  
 32 of the State to the Parliament of the Commonwealth of the matters  
 33 covered by subsection 30L(3).

34 ***law enforcement officer*** means:

- 35 (a) a member of a police force or police service; or
- 36 (b) a person appointed to a position for the purpose of being
- 37 trained as a member of a police force or police service; or

1 (c) a person who has the powers and duties of a member of a  
2 police force or police service;  
3 and, without limiting paragraphs (a), (b) and (c), includes a police  
4 reservist, a police recruit, a police cadet, a junior constable, a  
5 police medical officer, a special constable, an ancillary constable  
6 or a protective services officer.

7 **local government employee**, of a State, means:

- 8 (a) an employee of a local government employer of the State; or  
9 (b) any other employee in the State of a kind specified in the  
10 regulations.

11 **local government employer**, of a State, means an employer that is:

- 12 (a) a body corporate that is established for a local government  
13 purpose by or under a law of a State; or  
14 (b) a body corporate in which a body to which paragraph (a)  
15 applies has, or 2 or more such bodies together have, a  
16 controlling interest; or  
17 (c) a person who employs individuals for the purposes of an  
18 unincorporated body that is established for a local  
19 government purpose by or under a law of a State; or  
20 (d) any other body corporate that is a local government body in  
21 the State of a kind specified in the regulations; or  
22 (e) any other person who employs individuals for the purposes of  
23 an unincorporated body that is a local government body in  
24 the State of a kind specified in the regulations.

25 **referral law**, of a State, means the law of the State that refers  
26 matters, as mentioned in subsection 30L(1), to the Parliament of  
27 the Commonwealth.

28 **referred provisions** means the provisions of this Division to the  
29 extent to which they deal with matters that are included in the  
30 legislative powers of the Parliaments of the States.

31 **referred subject matters** means any of the following:

- 32 (a) terms and conditions of employment, including any of the  
33 following:  
34 (i) minimum terms and conditions of employment,  
35 (including employment standards and minimum wages);

- 
- 1 (ii) terms and conditions of employment contained in  
 2 instruments (including instruments such as awards,  
 3 determinations and enterprise-level agreements);  
 4 (iii) bargaining in relation to terms and conditions of  
 5 employment;  
 6 (iv) the effect of a transfer of business on terms and  
 7 conditions of employment;  
 8 (b) terms and conditions under which an outworker entity may  
 9 arrange for work to be performed for the entity (directly or  
 10 indirectly), if the work is of a kind that is often performed by  
 11 outworkers;  
 12 (c) rights and responsibilities of persons, including employees,  
 13 employers, independent contractors, outworkers, outworker  
 14 entities, associations of employees or associations of  
 15 employers, being rights and responsibilities relating to any of  
 16 the following:  
 17 (i) freedom of association in the context of workplace  
 18 relations, and related protections;  
 19 (ii) protection from discrimination relating to employment;  
 20 (iii) termination of employment;  
 21 (iv) industrial action;  
 22 (v) protection from payment of fees for services related to  
 23 bargaining;  
 24 (vi) sham independent contractor arrangements;  
 25 (vii) standing down employees without pay;  
 26 (viii) union rights of entry and rights of access to records;  
 27 (d) compliance with, and enforcement of, this Act;  
 28 (e) the administration of this Act;  
 29 (f) the application of this Act;  
 30 (g) matters incidental or ancillary to the operation of this Act or  
 31 of instruments made or given effect under this Act;  
 32 but does not include any excluded subject matter.

33 **referring State:** see section 30L.

34 **State public sector employee,** of a State, means:

- 35 (a) an employee of a State public sector employer of the State; or  
 36 (b) any other employee in the State of a kind specified in the  
 37 regulations;

1 and includes a law enforcement officer of the State.

2 **State public sector employer**, of a State, means an employer that  
3 is:

4 (a) the State, the Governor of the State or a Minister of the State;  
5 or

6 (b) a body corporate that is established for a public purpose by or  
7 under a law of the State, by the Governor of the State or by a  
8 Minister of the State; or

9 (c) a body corporate in which the State has a controlling interest;  
10 or

11 (d) a person who employs individuals for the purposes of an  
12 unincorporated body that is established for a public purpose  
13 by or under a law of the State, by the Governor of the State or  
14 by a Minister of the State; or

15 (e) any other employer in the State of a kind specified in the  
16 regulations;

17 and includes a holder of an office of the State whom the State's  
18 referral law provides is to be taken, for the purposes of this Act, to  
19 be an employer of law enforcement officers of the State.

20 **transition reference** of a State means the reference by the  
21 Parliament of the State to the Parliament of the Commonwealth of  
22 the matters covered by subsection 30L(5).

23 (2) Words or phrases in the definition of **excluded subject matter** in  
24 subsection (1), or in the definition of **referred subject matters** in  
25 subsection (1), that are defined in this Act (other than in this  
26 Division) have, in that definition, the meanings set out in this Act  
27 as in force on 1 July 2009.

### 28 **30L Meaning of referring State**

#### 29 *Reference of matters by State Parliament to Commonwealth* 30 *Parliament*

31 (1) A State is a **referring State** if the Parliament of the State has, after  
32 1 July 2009 but on or before 1 January 2010, referred the matters  
33 covered by subsections (3), (4) and (5) in relation to the State to the  
34 Parliament of the Commonwealth for the purposes of paragraph  
35 51(xxxvii) of the Constitution:

- 1 (a) if and to the extent that the matters are not otherwise included  
2 in the legislative powers of the Parliament of the  
3 Commonwealth (otherwise than by a reference under

## **Schedule 3A—Treatment of State awards and State employment agreements of Division 2B referring States**

### **Part 1—Preliminary**

#### **1 Meanings of *employer* and *employee***

In this Schedule, *employer* and *employee* have their ordinary meanings.

### **Part 2—Division 2B State instruments**

#### **2 What are Division 2B State instruments?**

(1) A *Division 2B State instrument* is a Division 2B State award (see item 3) or a Division 2B State employment agreement (see item 5).

(2) Subject to subitem (3), a *State award* is an instrument in relation to which the following conditions are satisfied:

- (a) the instrument regulates terms and conditions of employment;
- (b) the instrument was made under a State industrial law by a State industrial body;
- (c) the instrument is referred to in that law as an award.

Note: This definition does not apply to a reference in a provision of this Act to a State award if the provision expressly refers to the meaning that was given by the WR Act.

(3) The regulations may provide that an instrument of a specified kind:

- (a) is a *State award*; or
- (b) is not a *State award*.

(4) Subject to subitem (5), a *State employment agreement* is:

- (a) an agreement in relation to which the following conditions are satisfied:
  - (i) the agreement is between an employer and one or more employees of the employer, or between an employer and an association of employees registered under a State industrial law;
  - (ii) the agreement determines terms and conditions of employment of one or more employees of the employer;

- 
- 1 (iii) the agreement was made under a State industrial law; or  
2 (b) a determination in relation to which the following conditions  
3 are satisfied:  
4 (i) the determination determines terms and conditions of  
5 employment;  
6 (ii) the determination was made under a State industrial law  
7 by a State industrial body;  
8 (iii) the determination was made in a situation in which  
9 parties who were negotiating for the making of an  
10 agreement of a kind described in paragraph (a) had not  
11 been able to reach an agreement;  
12 (iv) the purpose of the determination was to resolve the  
13 matters that were at issue in those negotiations.

- 27 (7) A State employment agreement referred to in paragraph (6)(a) or (b) is  
28 an *individual State employment agreement*.

### 29 **3 Division 2B State awards**

- 30 (1) If, immediately before the Division 2B referral commencement:  
31 (a) a State award (the *source award*) was in operation under a  
32 State industrial law of a Division 2B referring State (the  
33 *source State*); and  
34 (b) the source award covered (however described in the source  
35 award or a relevant law of the source State) employers and  
36 employees who become Division 2B State reference

20 determination of a State industrial body or a court of the source State  
21 that was in operation immediately before the Division 2B referral  
22 commencement, the terms of the Division 2B State award are taken to  
23 be similarly affected by the terms of that order, decision or  
24 determination.

25 **4 The employees, employers etc. who are covered by a**  
26 **Division 2B State award and to whom it *applies***

27 ***Meaning of covers***

28 (1) A Division 2B State award ***covers*** the same employees, employers,  
29 outworker entities and any other persons that the source award covered  
30 (however described in the award or a relevant law of the source State)  
31 immediately before the Division 2B referral commencement.

32 Note: The expression ***covers*** is used to indicate the range of employees, employers etc. to  
33 whom the Division 2B State award potentially ***applies*** (see subitem (5)). The  
34 employees, employers etc. who are within this range will depend on the terms of the  
35 award, and on any relevant provisions of the law of the source State.

36 (2) The Division 2B State award also ***covers*** any employees who become  
37 employed by an employer on or after the Division 2B referral

1 commencement, and who would have been covered by the source award  
2 if they had become so employed immediately before that  
3 commencement.

  - 18 (b) the employer did not employ employees to do that kind of  
19 work immediately before that commencement;

20 then the Division 2B State award also does not *cover* any of the  
21 following, in relation to that kind of work:

- 22 (c) the employer;
- 23 (d) employees of the employer;
- 24 (e) any other persons, in relation to the employer or employees  
25 of the employer.

26 ***Meaning of applies***

- 27 (5) A Division 2B State award *applies* to the same employees, employers,  
28 outworker entities and any other persons that the Division 2B State  
29 award covers as would have been required by the law of the source  
30 State to comply with terms of the source award, or entitled under the  
31 law of the source State to enforce terms of the source award, if:
- 32 (a) the State had not been a referring State; and
  - 33 (b) the law of the source State had continued to apply.

34 Note 1: The expression *applies* is used to indicate the range of employees, employers etc. who  
35 are required to comply with, or can enforce, the terms of the Division 2B State award.

26 (1) If, immediately before the Division 2B referral commencement:  
27 (a) a State employment agreement (the *source agreement*) was  
28 in operation under a State industrial law of a Division 2B  
29 referring State (the *source State*); and  
30 (b) the source agreement covered (however described in the  
31 source agreement or a relevant law of the source State)  
32 employers and employees who become Division 2B State  
33 referral employers and Division 2B State referral employees

---

1 on the Division 2B referral commencement (whether or not  
2 the source agreement also covered other persons);

3 a ***Division 2B State employment agreement*** is taken to come into  
4 operation immediately after the Division 2B referral commencement.

5 Note 1: A Division 2B State employment agreement is a notional federal instrument derived  
6 from the source agreement.

7 Note 2: In addition to provisions of this Schedule, the following other provisions affect the  
8 existence of Division 2B State employment agreements:

9 (a) Division 2 of Part 2 of Schedule 6 (which deals with the  
10 enterprise instrument modernisation process);

11 (b) Schedule 11 (which deals with transfer of business).

12 Note 3: For the meanings of ***Division 2B referral commencement***, ***Division 2B referring State***,  
13 ***Division 2B State reference employee*** and ***Division 2B State reference employer***, see  
14 items 2 and 2A of Schedule 3.

15 (2) Subject to this Schedule, the Division 2B State employment agreement  
16 is taken to include the same terms as were in the source agreement  
17 immediately before the Division 2B referral commencement.

18 ***State employment agreements that come into operation on or***  
19 ***after the Division 2B referral commencement***

20 (3) If, on or after the Division 2B referral commencement:

21 (a) a State employment agreement (the ***source agreement***)  
22 comes into operation under a State industrial law of a  
23 Division 2B referring State (the ***source State***); and

24 (b) the source agreement covers (however described in the  
25 source agreement or a relevant law of the source State)  
26 employers and employees who are Division 2B State referral  
27 employers and Division 2B State referral employees when  
28 the source agreement comes into operation (whether or not  
29 the source agreement also covers other persons);

30 a ***Division 2B State employment agreement*** is taken to come into  
31 operation immediately after the source agreement comes into operation.

32 Note 1: A Division 2B State employment agreement is a notional federal instrument derived  
33 from the source agreement.

34 Note 2: There is limited scope for State employment agreements that cover Division 2B State  
35 referral employers and employees to come into operation on or after the Division 2B  
36 referral commencement: see Part 6 of this Schedule.

37 Note 3: In addition to provisions of this Schedule, the following other provisions affect the  
38 existence of Division 2B State employment agreements:

17 **6 The employees, employers etc. who are covered by a**  
18 **Division 2B State employment agreement and to whom**  
19 **it applies**

20 *Meaning of covers*

21 (1) A Division 2B State employment agreement *covers* the same  
22 employees, employers and any other persons that the source agreement  
23 covered (however described in the agreement or a relevant law of the  
24 source State) immediately before the Division 2B State employment  
25 agreement came into operation.

26 Note: The expression *covers* is used to indicate the range of employees, employers etc. to  
27 whom the Division 2B State employment agreement potentially *applies* (see  
28 subitem (4)). The employees, employers etc. who are within this range will depend on  
29 the terms of the agreement, and on any relevant provisions of the law of the source  
30 State.

31 (2) The Division 2B State employment agreement also *covers* any  
32 employees who become employed by an employer on or after the time  
33 when the agreement came into operation, and who would have been  
34 covered by the source agreement if they had become so employed  
35 immediately before that time.

- 1 (3) However, the Division 2B State employment agreement does not *cover*:  
2 (a) any employees or employers that are not Division 2B State  
3 reference employees or Division 2B State reference  
4 employers; or  
5 (b) any employees or employers that are covered by an  
6 award-based transitional instrument.

7 *Meaning of **applies***

- 8 (4) A Division 2B State employment agreement *applies* to the same  
9 employees, employers and any other persons that the Division 2B State  
10 employment agreement covers as would have been required by the law  
11 of the source State to comply with terms of the source agreement, or  
12 entitled under the law of the source State to enforce terms of the source  
13 agreement, if:  
14 (a) the source State had not been a referring State; and  
15 (b) the law of the source State had continued to apply.

16 Note 1: The expression *applies* is used to indicate the range of employees, employers etc. who  
17 are required to comply with, or can enforce, the terms of the Division 2B State  
18 employment agreement.

19 Note 2: The Division 2B State employment agreement does not apply to any employers,  
20 employees or other persons that it does not cover, whether because of subitem (3) or  
21 otherwise.

22 *Item has effect subject to other provisions*

- 23 (5) This item has effect subject to:  
24 (a) the instrument interaction rules (see item 11); and  
25 (b) the termination of Division 2B State instruments as referred  
26 to in item 18; and  
27 (c) Division 2 of Part 5 of this Schedule (which deals with  
28 interaction between Division 2B State instruments and FW  
29 Act modern awards, enterprise agreements and workplace  
30 determinations); and  
31 (d) Schedule 11 (which deals with transfer of business).

32 *References to laws of States*

- 33 (6) References in this item to the law of a State are references to the law of  
34 the State as in force immediately before the Division 2B referral  
35 commencement.

---

**7 Terms about disputes relating to matters arising under Division 2B State awards**

- (1) If the source award for a Division 2B State award includes a term that provides for disputes relating to matters arising under the award to be settled by:
- (a) a State industrial body; or
  - (b) a person who is independent of the employers, employees or organisations covered by the source award;
- the Division 2B State award is taken not to include that term.
- (2) Each Division 2B State award is taken to include the model term that is prescribed by the regulations for dealing with disputes relating to matters arising under Division 2B State awards.
- Note: This subitem applies whether or not the source award included a term as mentioned in subitem (1).
- (3) The model term does not apply to disputes about matters arising under the source award before the Division 2B referral commencement.
- (4) The model term, as taken to be included in a Division 2B State award:
- (a) cannot be varied; and
  - (b) cannot be removed from the award.

**8 Terms about disputes relating to matters arising under Division 2B State employment agreements**

- (1) This item applies if the source agreement for a Division 2B State employment agreement includes a term that provides for disputes relating to matters arising under the agreement to be settled by:
- (a) a State industrial body; or
  - (b) a person who is independent of the employers, employees or organisations covered by the source agreement.
- (2) Item 13 of this Schedule does not apply in relation to the term.
- Note: Item 13 would otherwise result in references in the term to a State industrial body having effect as if they were references to FWA.
- (3) FWA must, on application in accordance with subitem (4), vary the term in accordance with the application.
- (4) For the purpose of subitem (3), an application must be made:

- 1 (a) by an employer to which the Division 2B State employment  
2 agreement applies, or by an organisation that is entitled to  
3 represent the industrial interests of such an employer, with  
4 the consent of:  
5 (i) one or more employees to whom the agreement applies;  
6 or  
7 (ii) an organisation that is entitled to represent the industrial  
8 interests of one or more such employees; or  
9 (b) by an employee to whom the Division 2B State employment  
10 agreement applies, or by an organisation that is entitled to  
11 represent the industrial interests of such an employee, with  
12 the consent of:  
13 (i) an employer to which the Division 2B State  
14 employment agreement applies; or  
15 (ii) an organisation that is entitled to represent the industrial  
16 interests of such an employer.

17 **9 Application to Division 2B State instruments of provisions**  
18 **of FW Act about dealing with disputes**

- 19 (1) Subdivision B of Division 2 of Part 6-2 of the FW Act applies  
20 (including for the purpose of section 595 of the FW Act) as follows:  
21 (a) the Subdivision applies in relation to the model term that is  
22 taken by item 7 to be included in a Division 2B State award  
23 in the same way as the Subdivision applies in relation to a  
24 term in a modern award that provides a procedure for dealing  
25 with disputes;  
26 (b) the Subdivision applies in relation to a term to which item 8  
27 applies that is included in a Division 2B State employment  
28 agreement in the same way as the Subdivision applies in  
29 relation to a term in an enterprise agreement that provides a  
30 procedure for dealing with disputes.  
31 (2) The reference in subsections 739(5) and 740(4) of the FW Act to a  
32 decision that is inconsistent with this Act, or a fair work instrument that  
33 applies to the parties, is taken to include a reference to a decision that is  
34 inconsistent with a Division 2B State instrument that applies to the  
35 parties.

---

**10 Division 2B State instruments continue to be subject to the same instrument content rules**

- (1) The instrument content rules (as in force immediately before the Division 2B referral commencement) of the source State apply, in relation to a Division 2B State instrument, as if:
- (a) the rules were provisions of a law of the Commonwealth; and
  - (b) any references in the rules to State awards or State employment agreements (however described in the rules) were instead (respectively) references to Division 2B State awards or Division 2B State employment agreements; and
  - (c) any other modifications of those rules prescribed by the regulations were made.
- (2) *Instrument content rules*, in relation to a State, are provisions of a law of the State of any of the following kinds:
- (a) provisions about what may, or must, be included in an instrument;
  - (b) provisions to the effect that a particular term of an instrument is of no effect (however described):
    - (i) either completely or to a limited extent; and
    - (ii) either permanently or for a limited period;
  - (c) provisions to the effect that a particular term is taken to be included in an instrument.

**11 Division 2B State instruments continue to be subject to the same instrument interaction rules**

- (1) The instrument interaction rules (as in force immediately before the Division 2B referral commencement) of the source State apply, in relation to a Division 2B State instrument, as if:
- (a) the rules were provisions of a law of the Commonwealth; and
  - (b) any references in the rules to State awards or State employment agreements (however described in the rules) were instead (respectively) references to Division 2B State awards or Division 2B transitional State employment agreements; and
  - (c) any other modifications of those rules prescribed by the regulations were made.

---

1 (2) ***Instrument interaction rules***, in relation to a State, are provisions of a  
2 law of the State, the effect of which is that:

3 (a) one instrument has priority over, or excludes, another  
4 instrument:

5 (i) either completely or to a particular extent; and

6 (ii) either permanently or for a particular period; or

7 (b) one instrument ceases to operate because of another  
8 instrument:

9 (i) either completely or to a particular extent; and

10 (ii) either permanently or for a particular period.

11 **12 Division 2B State awards continue to be subject to the**  
12 **same outworker interaction rules**

13 (1) The outworker interaction rules (as in force immediately before the  
14 Division 2B referral commencement) of the source State apply, in  
15 relation to a Division 2B State award, as if:

16 (a) the rules were provisions of a law of the Commonwealth; and

17 (b) any references in the rules to State awards (however  
18 described in the rules) were instead references to Division 2B  
19 State awards; and

20 (c) any other modifications of those rules prescribed by the  
21 regulations were made.

22 (2) ***Outworker interaction rules***, in relation to a State, are provisions of a  
23 law of the State, the effect of which is that:

24 (a) a State award prevails over, or excludes, a law of the State  
25 relating to outworkers; or

26 (b) a State award has effect subject to a law of the State relating  
27 to outworkers.

28 **13 References in Division 2B State instruments to State**  
29 **industrial bodies**

30 (1) Subject to subitem (2), if a term of a Division 2B State instrument is  
31 expressed to confer a power or function on a State industrial body, that  
32 term has effect as if references in it to the body were instead references  
33 to FWA.

**Schedule 2** Transitional matters related to State referrals under Division 2B of Part 1-3 of the Fair Work Act 2009

**Part 1** Amendment of the Fair Work (Transitional Provisions and Consequential Amendments) Act 2009

---

1 (2) If a term of a Division 2B State instrument is expressed to confer a  
2 power or function on the registrar, or a deputy registrar, of a State  
3 industrial body, that term has effect on and after the Division 2B  
4 referral commencement as if references in it to the registrar or a deputy  
5 registrar were instead references to the General Manager of FWA.

6 (3) This item has effect subject to:  
7 (a) a contrary intention in this Act; and  
8 (b) the regulations.

9 Note 1: A Division 2B State award will be taken not to include a term from the source award  
10 that provides for the settlement of disputes relating to matters arising under the award:  
11 see item 7.

12 Note 2: This item does not apply to a term of a Division 2B State employment agreement that  
13 provides for the settlement of disputes relating to matters arising under the agreement:  
14 see item 8.

15 **14 Non-accruing entitlements: counting service under the**  
16 **source award or source agreement**

17 *General rule*

18 (1) Subitem (2) applies for the purpose of determining the entitlements of a  
19 Division 2B State reference employee under a Division 2B State  
20 instrument (other than an entitlement to leave of a kind to which  
21 item 15 applies).

22 (2) Service of the employee with an employer before the Division 2B  
23 referral commencement that counted for the purpose of the application  
24 to the employee of the source award or source agreement also counts as  
25 service of the employee with the employer for the purpose of the  
26 application to the employee of the Division 2B State instrument.

27 *No double entitlement*

28 (3) If, before the Division 2B referral commencement, the employee has  
29 already had the benefit of an entitlement, the amount of which was  
30 calculated by reference to a period of service, subitem (2) does not  
31 result in that period of service with the employer being counted again  
32 when calculating the employee's entitlements of that kind under the  
33 Division 2B State instrument.

34 (4) To avoid doubt, subitem (3) does not require an employee to serve any  
35 initial qualifying period of service for long service leave again.

---

1 Note: For how the kinds of matters covered by this item and items 15 and 16 are dealt with in  
2 relation to entitlements under the National Employment Standards, see Division 2 of  
3 Part 3 of Schedule 4.

4 **15 Accruing entitlements: leave accrued immediately before**  
5 **the Division 2B referral commencement**

- 6 (1) This item applies to leave of the following kinds:  
7 (a) annual leave (however described) that accrues to an  
8 employee;  
9 (b) personal leave or carer's leave (however described) that  
10 accrues to an employee.
- 11 (2) If a Division 2B referral employee to whom a Division 2B State  
12 instrument applies had, immediately before the Division 2B referral  
13 commencement, an accrued entitlement to an amount of leave to which  
14 this item applies (whether the leave accrued under the source award or  
15 source agreement, or under a State industrial law), the accrued leave is  
16 taken to have accrued under the Division 2B State instrument.

17 **16 Leave that is being, or is to be, taken under the source**  
18 **award or source agreement**

- 19 (1) If a Division 2B State reference employee was, immediately before the  
20 Division 2B referral commencement, taking a period of leave under the  
21 source award or source agreement, the employee is entitled to continue  
22 on that leave under the Division 2B State instrument for the remainder  
23 of the period.
- 24 (2) If a Division 2B State reference employee has, before the Division 2B  
25 referral commencement, taken a step that the employee is required to  
26 take so that the employee can, on or after the Division 2B referral  
27 commencement, take a period of leave under the source award or source  
28 agreement, the employee is taken to have taken the step under the  
29 Division 2B State instrument.
- 30 (3) The regulations may deal with other matters relating to how a  
31 Division 2B State instrument applies to leave that, immediately before  
32 the Division 2B referral commencement, is being, or is to be, taken by a  
33 Division 2B State reference employee under the source award or source  
34 agreement.

---

**17 No loss of accrued rights or liabilities when Division 2B State instrument terminates or ceases to apply**

- (1) If a Division 2B State instrument terminates, or ceases to apply in relation to a person, that does not affect:
- (a) any right or liability that a person acquired, accrued or incurred before the instrument terminated or ceased to apply; or
  - (b) any investigation, legal proceeding or remedy in respect of any such right or liability.
- (2) Any such investigation, legal proceeding or remedy may be instituted, continued or enforced as if the Division 2B State instrument had not terminated or ceased to apply.
- (3) This item has effect subject to a contrary intention in this Act or in the FW Act.

**Part 3—Variation and termination of Division 2B State instruments**

**18 Division 2B State instruments can only be varied or terminated in limited circumstances**

- (1) A Division 2B State instrument cannot be varied except under:
- (a) a provision of this Part or the regulations; or
  - (b) item 8 (which deals with terms about disputes relating to matters arising under Division 2B State employment agreements); or
  - (c) item 40 (which deals with resolving difficulties with the interaction between Division 2B State instruments and the National Employment Standards); or
  - (d) Part 6 of this Schedule (which deals with ongoing operation of State laws for transitional purposes); or
  - (e) Division 2 of Part 2 of Schedule 6 (which deals with the enterprise instrument modernisation process); or
  - (f) item 20 of Schedule 9 (which deals with variation of Division 2B State awards in annual wage reviews); or
  - (g) Schedule 11 (which deals with transfer of business).

- 
- 1 (2) A Division 2B State instrument cannot be terminated (or otherwise  
2 brought to an end) except under:  
3 (a) a provision of this Part or the regulations; or  
4 (b) Part 6 of this Schedule; or  
5 (c) Division 2 of Part 2 of Schedule 6; or  
6 (d) Schedule 11.

7 **19 Variation to remove ambiguities etc.**

- 8 (1) On application by a person covered by a Division 2B State instrument,  
9 FWA may make a determination varying the instrument:  
10 (a) to remove an ambiguity or uncertainty in the instrument; or  
11 (b) if the instrument is a Division 2B State employment  
12 agreement—to resolve an uncertainty or difficulty relating to  
13 the interaction between the instrument and a modern award;  
14 or  
15 (c) to remove terms that are inconsistent with Part 3-1 of the FW  
16 Act (which deals with general protections), or to vary terms  
17 to make them consistent with that Part.

18 Note: For variation of a Division 2B State instrument to resolve an uncertainty or difficulty  
19 relating to the interaction between the instrument and the National Employment  
20 Standards, see item 40.

- 21 (2) A variation of a Division 2B State instrument operates from the day  
22 specified in the determination, which may be a day before the  
23 determination is made.

24 **20 Variation on referral by Australian Human Rights  
25 Commission**

- 26 (1) This item applies if a Division 2B State instrument is referred to FWA  
27 under section 46PW of the *Australian Human Rights Commission Act*  
28 *1986* (which deals with discriminatory industrial instruments).  
29 (2) If the instrument is a Division 2B State award, section 161 of the FW  
30 Act applies in relation to the referral of the instrument as if the  
31 instrument were a modern award.  
32 (3) If the instrument is a Division 2B State employment agreement,  
33 section 218 of the FW Act applies in relation to the referral of the  
34 instrument as if the instrument were an enterprise agreement.

---

1 **21 Division 2B State awards: automatic termination after 12**  
2 **months**

3 (1) A Division 2B State award terminates at the end of 12 months after the  
4 Division 2B referral commencement.

5 (2) A term of a Division 2B State award that provides for the award to  
6 terminate before the end of that 12 month period is of no effect.

7 (3) This item does not apply to a Division 2B enterprise award.

8 Note: Schedule 6 (modern enterprise awards) applies to Division 2B enterprise awards.

9 **22 Collective Division 2B State employment agreements:**  
10 **termination by agreement**

11 Subdivision C of Division 7 of Part 2-4 of the FW Act (which deals  
12 with termination of enterprise agreements by employers and employees)  
13 applies in relation to a collective Division 2B State employment  
14 agreement as if a reference to an enterprise agreement included a  
15 reference to a collective Division 2B State employment agreement.

16 **23 Collective Division 2B State employment agreements:**  
17 **termination by FWA**

18 Subdivision D of Division 7 of Part 2-4 of the FW Act (which deals  
19 with termination of enterprise agreements after their nominal expiry  
20 date) applies in relation to a collective Division 2B State employment  
21 agreement as if a reference to an enterprise agreement included a  
22 reference to a collective Division 2B State employment agreement.

23 **24 Individual Division 2B State employment agreements:**  
24 **termination by agreement**

25 (1) The employee and employer covered by an individual Division 2B State  
26 employment agreement (the *Division 2B agreement*) may make a  
27 written agreement (a *termination agreement*) to terminate the  
28 Division 2B agreement in accordance with the following requirements:

29 (a) the termination agreement must be signed by the employee  
30 and the employer;

31 (b) if the employee is under 18, it must also be signed by a  
32 parent or guardian of the employee;

33 (c) the signatures must be witnessed.

- 
- 1 (2) The termination has no effect unless it has been approved by FWA.
- 2 (3) The employer or employee may apply to FWA for approval of the  
3 termination agreement. The application must be made:  
4 (a) within 14 days after the termination agreement was made; or  
5 (b) if in all the circumstances FWA considers it fair to extend  
6 that period—within such further period as FWA allows.
- 7 (4) If an application for FWA to approve the termination agreement is  
8 made under subitem (3), FWA must approve the termination of the  
9 Division 2B agreement if:  
10 (a) FWA is satisfied that the requirements of subitem (1) have  
11 been complied with; and  
12 (b) FWA is satisfied that there are no other reasonable grounds  
13 for believing that the employee has not agreed to the  
14 termination.
- 15 (5) If the termination is approved under subitem (4), the termination  
16 operates from the day specified in the decision to approve the  
17 termination.

18 **25 Individual Division 2B State employment agreements:**  
19 **termination conditional on enterprise agreement**

- 20 (1) This item provides for the making of an instrument (a *conditional*  
21 *termination*) that will have the effect of terminating an individual  
22 Division 2B State employment agreement (the *Division 2B agreement*)  
23 if:  
24 (a) an enterprise agreement (the *proposed enterprise agreement*)  
25 is made that covers the employee and the employer; and  
26 (b) the proposed enterprise agreement comes into operation.
- 27 (2) If the Division 2B agreement has not passed its nominal expiry date, the  
28 conditional termination must be a written agreement signed by the  
29 employer and the employee. The signatures must be witnessed.
- 30 (3) If the Division 2B agreement has passed its nominal expiry date, the  
31 conditional termination must be in writing and signed either by the  
32 employee or the employer. The signature must be witnessed.

**Schedule 2** Transitional matters related to State referrals under Division 2B of Part 1-3 of the Fair Work Act 2009

**Part 1** Amendment of the Fair Work (Transitional Provisions and Consequential Amendments) Act 2009

- 
- 1 (4) If the conditional termination is signed by the employee, and the  
2 employee is under 18, it must also be signed by a parent or guardian of  
3 the employee.
- 4 (5) Any other requirements of the regulations relating to the form, content  
5 or making of the conditional termination must also be complied with.
- 6 (6) The employer must give the employee a copy of the conditional  
7 termination if:
- 8 (a) the conditional termination is an agreement signed by the  
9 employee and the employer in the circumstances covered by  
10 subitem (2); or
- 11 (b) the conditional termination is signed by the employer in the  
12 circumstances covered by subitem (3).
- 13 Note 1: For compliance with this obligation, see subitem 4B(1) of Schedule 16.
- 14 Note 2: Failure to comply with this obligation does not affect the operation of subitem (8).
- 15 (7) The conditional termination must accompany any application to FWA  
16 for approval of the proposed enterprise agreement under section 185 of  
17 the FW Act.
- 18 Note 1: For compliance with this obligation, see subitem 4B(2) of Schedule 16.
- 19 Note 2: Failure to comply with this obligation does not affect the operation of subitem (8), or  
20 the validity of an approval by FWA of the proposed enterprise agreement.
- 21 (8) If the requirements of subitems (2) to (5) have been complied with in  
22 relation to the conditional termination, the Division 2B agreement  
23 terminates when the proposed enterprise agreement comes into  
24 operation.

25 **26 Individual Division 2B State employment agreements:**  
26 **unilateral termination with FWA's approval**

- 27 (1) This item applies to an employer or employee:
- 28 (a) to whom an individual Division 2B State employment  
29 agreement (the *Division 2B agreement*) that has passed its  
30 nominal expiry date applies; and
- 31 (b) who wants to terminate the Division 2B agreement.
- 32 (2) The employer or employee may:

- 
- 1 (a) make a written declaration that identifies the Division 2B  
2 agreement and that states that the employer or employee  
3 wants to terminate the agreement; and  
4 (b) apply to FWA for the approval of the termination.
- 5 (3) The employer or employee cannot make an application as mentioned in  
6 paragraph (2)(b) unless, at least 14 days before the day on which the  
7 application is made, the employer or employee gives the other of them a  
8 notice complying with the following requirements:
- 9 (a) the notice must identify the Division 2B agreement;  
10 (b) the notice must state that the employer or employee intends  
11 to apply to FWA for approval of the termination of the  
12 agreement;  
13 (c) the notice must state that, if FWA approves the termination,  
14 the agreement will terminate on the 90th day after the day on  
15 which FWA makes the approval decision;  
16 (d) the notice must comply with any other requirements of the  
17 regulations.
- 18 (4) FWA must approve the termination if FWA is satisfied that:
- 19 (a) the Division 2B agreement applies to the employer and the  
20 employee; and  
21 (b) the requirements of subitems (2) and (3) have been complied  
22 with.
- 23 (5) If FWA approves the termination, the Division 2B agreement terminates  
24 on the 90th day after the day on which FWA makes the approval  
25 decision.

26 **27 Meaning of *nominal expiry date* of Division 2B State**  
27 **employment agreement**

- 28 The *nominal expiry date* of a Division 2B State employment agreement  
29 is:
- 30 (a) the day on which the source agreement would nominally  
31 have expired under the relevant State industrial law of the  
32 source State; or  
33 (b) if that day falls after the end of a period of 3 years beginning  
34 on the Division 2B referral commencement—the last day of  
35 that 3 year period.

---

**28 Effect of termination**

If a Division 2B State instrument terminates, it ceases to cover (and can never again cover) any employees, employers or other persons.

**Part 4—Transition of employees from Division 2B State awards to FW Act modern awards**

**Division 1—FWA required to consider varying modern awards etc.**

**29 FWA to consider varying modern awards to continue effect of terms of Division 2B State awards**

- (1) During the period of 12 months starting on the Division 2B referral commencement, FWA:
- (a) must consider whether any modern awards should be varied to include terms in relation to which the following conditions are satisfied:
    - (i) the purpose of including the terms is to continue (in whole or in part) the effect of terms that are contained in a Division 2B State award, other than a Division 2B enterprise award;
    - (ii) the terms only relate to employees, employers or other persons covered by the Division 2B State award;
    - (iii) the terms deal with matters of a kind that are permitted by section 136 of the FW Act to be included in modern awards; and
  - (b) may make one or more determinations varying modern awards to include such terms.
- (2) Terms may be included in a modern award in accordance with this item despite section 154 of the FW Act.
- (3) Terms included in a modern award in accordance with this item:
- (a) take effect at the end of 12 months after the Division 2B referral commencement; and
  - (b) cease to have effect:
    - (i) at the end of 5 years after the Division 2B referral commencement; or

- 1 (ii) if the terms are expressed to cease to have effect at an  
2 earlier time—at that earlier time.

3 **30 FWA to consider making orders to continue effect of long**  
4 **service leave terms of Division 2B State awards**

- 5 (1) During the period of 12 months starting on the Division 2B referral  
6 commencement, FWA:  
7 (a) must consider whether any orders should be made in relation  
8 to which the following conditions are satisfied:  
9 (i) the purpose of making the order is to continue (in whole  
10 or in part) the effect of terms relating to long service  
11 leave that are contained in a Division 2B State award,  
12 other than a Division 2B enterprise award;  
13 (ii) the order only relates to employees, employers or other  
14 persons covered by the Division 2B State award; and  
15 (b) may make one or more such orders.
- 16 (2) An order under subitem (1):  
17 (a) takes effect at the end of 12 months after the Division 2B  
18 referral commencement; and  
19 (b) ceases to have effect:  
20 (i) at the end of 5 years after the Division 2B referral  
21 commencement; or  
22 (ii) if the order is expressed to cease to have effect at an  
23 earlier time—at that earlier time.
- 24 (3) Paragraph 675(1)(a) of the FW Act has effect as if it also included a  
25 reference to an order under subitem (1).
- 26 (4) To the extent that a term of a Division 2B State award, or of an  
27 enterprise agreement, is detrimental to an employee, in any respect,  
28 when compared to an order under subitem (1), the term of the award or  
29 agreement is of no effect.
- 30 Note: A term of a Division 2B State award, or of an enterprise agreement, that provides an  
31 entitlement that is at least as beneficial to an employee as a corresponding entitlement of  
32 the employee under the order will continue to have effect.
- 33 (5) The regulations may make provisions that apply to determining, for the  
34 purpose of this item, whether terms of a Division 2B State award or an

---

1 enterprise agreement are, or are not, detrimental in any respect when  
2 compared to an order under subitem (1).

3 **Division 2—Avoiding reductions in take-home pay**

4 **31 Termination of Division 2B State awards is not intended to**  
5 **result in reduction in take-home pay**

6 (1) The termination of a Division 2B State award by item 21 is not intended  
7 to result in a reduction in the take-home pay of employees or  
8 outworkers.

9 (2) An employee's or outworker's *take-home pay* is the pay an employee  
10 or outworker actually receives:

11 (a) including wages and incentive-based payments, and  
12 additional amounts such as allowances and overtime; but

13 (b) disregarding the effect of any deductions that are made as  
14 permitted by section 324 of the FW Act.

15 Note: Deductions permitted by section 324 of the FW Act may (for example) include  
16 deductions under salary sacrificing arrangements.

17 (3) An employee suffers a reduction in take-home pay to which this item  
18 applies if, and only if:

19 (a) when a Division 2B State award terminates because of  
20 item 21, the employee becomes a person to whom a modern  
21 award applies; and

22 (b) the employee is employed in the same position as (or a  
23 position that is comparable to) the position he or she was  
24 employed in immediately before the termination of the  
25 Division 2B State award; and

26 (c) the amount of the employee's take-home pay for working  
27 particular hours or for a particular quantity of work after the  
28 termination of the Division 2B State award is less than what  
29 would have been the employee's take-home pay for those  
30 hours or that quantity of work immediately before the  
31 termination; and

32 (d) that reduction in the employee's take-home pay is  
33 attributable to the termination of the Division 2B State  
34 award.

- 
- 1 (4) An outworker who is not an employee suffers a reduction in take-home  
2 pay to which this item applies if, and only if:
- 3 (a) when a Division 2B State award terminates because of  
4 item 21, the outworker becomes a person to whom outworker  
5 terms in a modern award relate; and
- 6 (b) the outworker is performing the same work as (or work that  
7 is similar to) the work he or she was performing immediately  
8 before the termination of the Division 2B State award; and
- 9 (c) the amount of the outworker's take-home pay for working  
10 particular hours or for a particular quantity of work after the  
11 termination of the Division 2B State award is less than what  
12 would have been the outworker's take-home pay for those  
13 hours or that quantity of work immediately before the  
14 termination; and
- 15 (d) that reduction in the outworker's take-home pay is  
16 attributable to the termination of the Division 2B State  
17 award.

18 **32 Orders remedying reductions in take-home pay**

19 *Employees*

- 20 (1) If FWA is satisfied that an employee, or a class of employees, to whom  
21 a modern award applies has suffered a reduction in take-home pay to  
22 which item 31 applies, FWA may make any order (a *take-home pay*  
23 *order*) requiring, or relating to, the payment of an amount or amounts to  
24 the employee or employees that FWA considers appropriate to remedy  
25 the situation.

26 *Outworkers*

- 27 (2) If FWA is satisfied that an outworker, or a class of outworkers, to  
28 whom outworker terms in a modern award relate has suffered a  
29 reduction in take-home pay to which item 31 applies, FWA may make  
30 any order (a *take-home pay order*) requiring, or relating to, the payment  
31 of an amount or amounts to the outworker or outworkers that FWA  
32 considers appropriate to remedy the situation.

33 *General provisions*

- 34 (3) FWA may make a take-home pay order only on application by:

- 
- 1 (a) an employee or outworker who has suffered a reduction in  
2 take-home pay to which item 31 applies; or  
3 (b) an organisation that is entitled to represent the industrial  
4 interests of such an employee or outworker; or  
5 (c) a person acting on behalf of a class of such employees or  
6 outworkers.

- 7 (4) If FWA is satisfied that an application for a take-home pay order has  
8 already been made in relation to an employee or a class of employees,  
9 or an outworker or a class of outworkers, FWA may dismiss any later  
10 application that is made under these provisions in relation to the same  
11 employee or employees, or the same outworker or outworkers.

12 **33 Ensuring that take-home pay orders are confined to the**  
13 **circumstances for which they are needed**

- 14 (1) FWA must not make a take-home pay order under item 32 in relation to  
15 an employee or class of employees, or an outworker or a class of  
16 outworkers, if:  
17 (a) FWA considers that the reduction in take-home pay is minor  
18 or insignificant; or  
19 (b) FWA is satisfied that the employee or employees, or  
20 outworker or outworkers, have been adequately compensated  
21 in other ways for the reduction.
- 22 (2) FWA must ensure that a take-home pay order is expressed so that:  
23 (a) it does not apply to an employee or outworker unless the  
24 employee or outworker has actually suffered a reduction in  
25 take-home pay to which item 31 applies; and  
26 (b) if the take-home pay payable to the employee or outworker  
27 under the modern award increases after the order is made,  
28 there is a corresponding reduction in any amount payable to  
29 the employee or outworker under the order.

30 **34 Take-home pay order continues to have effect so long as**  
31 **modern award continues to cover the employee or**  
32 **employees**

1 A take-home pay order made in relation to an employee or class of  
2 employees to whom a particular modern award applies continues to  
3 have effect in relation to those employees (subject to the terms of the  
4 order) for so long as the modern award continues to cover the employee  
5 or employees, even if it stops applying to the employee or employees  
6 because an enterprise agreement starts to apply.

7 **35 Inconsistency with modern awards and enterprise**  
8 **agreements**

9 A term of a modern award or an enterprise agreement has no effect in  
10 relation to an employee or outworker to the extent that it is less  
11 beneficial to the employee or outworker than a term of a take-home pay  
12 order that applies to the employee or outworker.

13 **36 Application of provisions of FW Act to take-home pay**  
14 **orders**

15 The FW Act applies as if the following provisions of that Act included a  
16 reference to a take-home pay order:

- 17 (a) subsection 675(2);  
18 (b) subsection 706(2).

19 Note: For compliance with take-home pay orders, see item 7 of Schedule 16 to this Act.

20 **Part 5—Division 2B State instruments and the FW**  
21 **Act**

22 **Division 1—Interaction between Division 2B State**  
23 **instruments and the National Employment**  
24 **Standards**

25 **37 The no detriment rule**

- 26 (1) To the extent that a term of a Division 2B State instrument is  
27 detrimental to an employee, in any respect, when compared to an  
28 entitlement of the employee under the National Employment Standards,  
29 the term of the instrument is of no effect.

30 Note 1: A term of a Division 2B State instrument that provides an entitlement that is at least as  
31 beneficial to an employee as a corresponding entitlement of the employee under the  
32 National Employment Standards will continue to have effect.

**Schedule 2** Transitional matters related to State referrals under Division 2B of Part 1-3 of the Fair Work Act 2009

**Part 1** Amendment of the Fair Work (Transitional Provisions and Consequential Amendments) Act 2009

- 
- 1 Note 2: Division 3 (which contains other general provisions about how the FW Act applies in  
2 relation to Division 2B State instruments) is also relevant to how the National  
3 Employment Standards apply in relation to employees to whom Division 2B State  
4 instruments apply.
- 5 Note 3: References to the National Employment Standards include a reference to the extended  
6 parental leave provisions and the extended notice of termination provisions (see  
7 sections 746 and 761 of the FW Act).
- 8 (2) If there is a dispute about the application of this item which must be  
9 resolved by FWA in accordance with item 40, FWA may compare the  
10 entitlements which are in dispute:
- 11 (a) on a 'line-by-line' basis, comparing individual terms; or  
12 (b) on a 'like-by-like' basis, comparing entitlements according to  
13 particular subject areas; or  
14 (c) using any combination of the above approaches FWA sees  
15 fit.
- 16 (3) Subitem (1) does not affect a term of a Division 2B State instrument  
17 that is permitted by a provision of the National Employment Standards  
18 as it has effect under item 38.
- 19 (4) The regulations may make provisions that apply to determining, for the  
20 purpose of this item, whether terms of a Division 2B State instrument  
21 are, or are not, detrimental in any respect when compared to  
22 entitlements under the National Employment Standards.

23 **38 Provisions of the NES that allow instruments to contain**  
24 **particular kinds of terms**

- 25 (1) The following provisions of the National Employment Standards have  
26 effect, on and after the Division 2B referral commencement, as if a  
27 reference to a modern award or an enterprise agreement included a  
28 reference to a Division 2B State instrument:
- 29 (a) section 63 (which allows terms dealing with averaging of  
30 hours of work);  
31 (b) section 93 (which allows terms dealing with cashing out and  
32 taking paid annual leave);  
33 (c) section 101 (which allows terms dealing with cashing out  
34 paid personal/carer's leave);  
35 (d) subsection 107(5) (which allows terms dealing with evidence  
36 requirements for paid personal/carer's leave etc.);

- 1 (e) subsection 115(3) (which allows terms dealing with
- 2 substitution of public holidays);
- 3 (f) section 118 (which allows terms dealing with an employee
- 4 giving notice to terminate his or her employment);
- 5 (g) subsections 121(2) and (3) (which allow terms specifying
- 6 situations in which the redundancy pay entitlement under
- 7 section 119 does not apply);
- 8 (h) section 126 (which allows terms providing for school-based
- 9 apprentices and trainees to be paid loadings in lieu).

10 (2) If:

- 11 (a) a Division 2B State instrument includes terms referred to in
- 12 subsection (1) of section 93 or 101 of the National
- 13 Employment Standards; but
- 14 (b) the terms do not include the requirements referred to in
- 15 subsection (2) of that section;

16 the instrument is taken to include terms that include the requirements.

### 17 **39 Shiftworker annual leave entitlement**

18 Subsections 87(3) to (5) of the FW Act apply in relation to an employee  
19 to whom a Division 2B State instrument applies in the same way as they  
20 apply to an award/agreement free employee.

21 Note: If the employee qualifies for the shiftworker annual leave entitlement under those  
22 subsections, the employee will be entitled to 5 (rather than 4) weeks of paid annual  
23 leave.

### 24 **40 Resolving difficulties about application of this Division**

25 (1) On application by a person covered by a Division 2B State instrument,  
26 FWA may make a determination varying the instrument:

- 27 (a) to resolve an uncertainty or difficulty relating to the
- 28 interaction between the instrument and the National
- 29 Employment Standards; or
- 30 (b) to make the instrument operate effectively with the National
- 31 Employment Standards.

32 (2) A variation of a Division 2B State instrument operates from the day  
33 specified in the determination, which may be a day before the  
34 determination is made.

---

**Division 2—Interaction between Division 2B State instruments and FW Act modern awards, enterprise agreements and workplace determinations**

**41 Modern awards and Division 2B State employment agreements**

*Collective Division 2B State employment agreements*

- (1) If a collective Division 2B State employment agreement and a modern award both apply to an employee, or to an employer or other person in relation to the employee, the Division 2B State employment agreement prevails over the modern award, to the extent of any inconsistency.

Note: This subitem has effect subject to item 42 of this Schedule, and to item 17 of Schedule 9 (which requires that the base rate of pay under a Division 2B State employment agreement must not be less than the modern award rate).

*Individual Division 2B State employment agreements*

- (2) While an individual Division 2B State employment agreement applies to an employee, or to an employer or other person in relation to an employee, a modern award does not apply to the employee, or to the employer or other person in relation to the employee.

Note 1: However, a modern award can continue to cover the employee while the individual Division 2B State employment agreement continues to apply.

Note 2: This subitem has effect subject to item 42 of this Schedule, and to item 17 of Schedule 9 (which requires that the base rate of pay under a Division 2B State employment agreement must not be less than the modern award rate).

**42 Terms of modern awards about outworker conditions continue to apply**

- (1) This item applies if, at a particular time:
- (a) a Division 2B State employment agreement applies to an employee; and
  - (b) outworker terms (within the meaning of the FW Act) in a modern award would, but for the Division 2B State employment agreement, apply to the employee.
- (2) Despite item 41 and despite any terms of the Division 2B State employment agreement that are detrimental to the employee in any

1 respect when compared to the terms of the modern award, the  
2 outworker terms apply at that time to the following persons:

- 3 (a) the employee;  
4 (b) the employer;  
5 (c) each employee organisation to which the modern award  
6 applies.

7 (3) To avoid doubt, to the extent to which terms of a modern award apply  
8 to an employee, an employer or an employee organisation because of  
9 subitem (2), the modern award applies to the employee, employer or  
10 organisation.

### 11 **43 Modern awards and Division 2B State awards**

#### 12 *Employees and employers*

13 (1) While a Division 2B State award that covers an employee, or an  
14 employer or other person in relation to the employee, is in operation, a  
15 modern award does not cover the employee, or the employer or other  
16 person in relation to the employee.

17 Note: When the Division 2B State award terminates, a modern award will start to cover the  
18 employee, or the employer or other person in relation to the employee.

#### 19 *Outworker entities*

20 (2) While a Division 2B State award that contains outworker terms that  
21 cover an outworker entity is in operation, outworker terms in a modern  
22 award do not cover the outworker entity.

23 Note: When the Division 2B State award terminates, a modern award will start to cover the  
24 outworker entity.

25 (3) *Outworker terms* in a Division 2B State award are terms that would be  
26 outworker terms as defined in the FW Act if they were in a modern  
27 award.

### 28 **44 FW Act enterprise agreements and workplace** 29 **determinations, and Division 2B State employment** 30 **agreements**

**Schedule 2** Transitional matters related to State referrals under Division 2B of Part 1-3 of the Fair Work Act 2009

**Part 1** Amendment of the Fair Work (Transitional Provisions and Consequential Amendments) Act 2009

---

*Collective Division 2B State employment agreements*

- (1) If an enterprise agreement or workplace determination (under the FW Act) starts to apply to an employee, or an employer or other person in relation to the employee, then a collective Division 2B State employment agreement ceases to cover (and can never again cover) the employee, or the employer or other person in relation to the employee.

Note 1: The fact that a collective Division 2B State employment agreement applies to employees does not prevent those employees and their employer from replacing that agreement at any time with an enterprise agreement, regardless of whether the collective Division 2B State employment agreement has passed its nominal expiry date.

Note 2: Industrial action must not be taken before the nominal expiry date of a collective Division 2B State employment agreement (see item 4 of Schedule 13).

*Individual Division 2B State employment agreements*

- (2) While an individual Division 2B State employment agreement applies to an employee, or to an employer in relation to the employee, an enterprise agreement or workplace determination (under the FW Act) does not apply to the employee, or the employer in relation to the employee.

**45 FW Act enterprise agreements and workplace determinations, and Division 2B State awards**

If an enterprise agreement or workplace determination (under the FW Act) applies to an employee, or an employer or other person in relation to the employee, then:

- (a) a Division 2B State award ceases to apply to the employee, and the employer or other person in relation to the employee; but
- (b) the Division 2B State award can (subject to the other provisions of this Part) continue to cover the employee, and the employer or other person in relation to the employee.

Note: Subject to the other provisions of this Part, the Division 2B State award can again start to apply to the employee, and the employer or other person in relation to the employee, if the enterprise agreement or workplace determination (under the FW Act) ceases to apply to the employee.
